Dear Parents.

As you may know, recent state legislation has been passed that may allow families to send their students to St. Charles Borromeo Catholic School, which otherwise, may not have been possible. Most of our parents want to know two things: 1) does my family qualify and 2) what would my tuition be? Please follow the steps outlined to answer those questions for your family.

Step 1: Does your family income fall in the following brackets? If yes, proceed to Step 2; if not, we are sorry but you are not eligible for a voucher.
